Chief Wooten said that the fiduciary falls on the Board he said that two-story option is the best option. Chief Wooten said that nobody else has approached the District with ideas or property so if the advisory wanted to pick a location they could. Cathy Morgan asked the Chief what option he would go with and the Chief said that with the back up and congestion on Oregon Ave he thinks that the Creswell Community Center property would be the best fit for a new Fire Station. There was some discussion about the Veterans Memorial that is currently in the plan to stay where it is. We could always call and have a conversation with the VA to see about moving the memorial if needed. Station Advisory Committee to build the new Fire Station on the Creswell Community Center location. Elena Connelly Seconded the Motion.
