Old Business:

- RFP Strategic Planning: Chief Wooten said that the Strategic Planning went very well there was not one objective that was deemed Life threatening or any that are considered legal risk. Joel Higdon said although he was only there for 1 day he enjoyed sitting back and listening to the different conversation on the different topics being discussed.
- Cloverdale Property: Chief Wooten said Don Hansen signed the paperwork from the Title Company and that we should see the money for the sale of the property in August 2019.

- Creswell Fire Station: Chief Wooten said they did the soil testing at the Creswell Community Center and that went well Michelle and Maddy with the City were present he said that we are almost ready to property swap after they test for asbestos. Joel asked about the VFW memorial and moving it to maybe a public park. Michelle Amberg said maybe we can help with the move of the memorial she has already had talks with the VFW about moving it. - New Auditor: Chief Wooten said he has heard back from 2 auditors that he has
 reached out to and he is going to recommend the one out of Albany he said he
 will have a proposal for decision at the July meeting.

New Business:

- **Election Results:** Chief Wooten said Jennifer Radcliffe retained her Position 4 and that Cheryl Shannon obtained Position 2.
- Board Resolution 19-04 Resolution: Adopt the Fiscal Year 2019-20 Budget, make appropriations and Impose and Categorize taxes. The Board of Directors of South Lane County Fire and Rescue meeting in a regular scheduled session on this 20th day of June 2019, hereby adopts the budget, as amended, in the amount of \$9,522,850. It is further resolved that the Board of Directors of South Lane County Fire and Rescue hereby impose the taxes provided for the adopted budget at the rate of \$1.0335 per \$1,000 of assessed value for operations: and \$.47 per \$1,000 of assessed value for local option tax, \$.30 per \$1,000 of assessed value from bond resources and that these taxes are imposed and categorized for the tax year 2019-20 upon the assessed value of all taxable property within the Fire District as of 1:00am July 1, 2019.
