Management Team Comments and Reports:

Chief Wooten:

- Chief Wooten advised the board that he did an end of the Fiscal year review and that we had 1.8 million in ambulance revenue and our unappropriated ending balance was 1.4 million. He said that we might have to do a supplemental budget later on. He also said that the management team has done a good job.
- Chief Wooten said that Fire season is upon us and we will probably see this in the next few weeks.
- We hired a temp person Annelies Cowan who was one of our residents to fill in on A Shift which is Chief Baird's shift. Chief Wooten said Annelies is a good fit and he is hoping she will test once we get set up with our new system that DC Raade is going to talk about.

Division Chief/Shift Commander Comments:

- Chief Raade: Chief Raade said that we do have a new hire and that he is working out really well and that he is on his shift. Chief Raade also said that they had a successful rescue several miles out the crew successfully rescued a person that was trapped under a vehicle 200 feet down an embankment.
- Chief Raade: We are going to subscribe to a new program for testing it is called National Testing Network with this program candidates test 1 time and it gets sent out to whoever they would like it to go to we will have a better chance of getting more candidates this way.

- Chief Baird: Chief Baird said we have a new budget for fleet and we are gearing up for Fire season because it is coming.
- Chief Baird: We are still working on bids and a new gate for the training yard so that project is not complete yet.
