Management Team Comments and Reports:

Chief Wooten: Chief Wooten said that we heard from Blake with Tactical Business and this year's GEMT money came through as \$37,000 and it should be around \$377,977 which is much more consistent with our previous reports. Chief Wooten said he is going to budget for another ambulance as well as some new Heart Monitors and CPR devices with this money.

Chief Wooten: Chief Wooten said that our employee that has been out sick is back and working on getting release backed to full time.

Chief Wooten: Chief Wooten said we now have a new email address for FOIA Request and it is FOIArequest@southlanefire.org. He also said that our website has been updated with current procedures on FOIA request.

Division Chief/Shift Commander Comments:

- Division Chief Joe Raade: DC Raade said that we have been helping out with the weekend COVID Vaccine Clinics that they have been having at the Lane County Fairgrounds, Autzen Stadium and LCC Campus.
- Division Chief Joe Raade: DC Raade said that the new Ambulance is in Service now and that it is out in the Bays and he is encouraging the Board to go out after the meeting and check it out.
